CASE MANAGEMENT ORDER

On October 6, 2005, the Court held a scheduling conference wherein it ordered all counsel of record to meet and discuss entry of a case management Order in this matter. As a result of that hearing, the Court Orders that the deadlines listed below will govern in this matter. Without leave of Court or written agreement of all parties, no deviation from these deadlines will be allowed:

- 11/7/2005 Plaintiffs shall propose a discovery group of 20 Plaintiffs.
- 11/30/2005 Plaintiffs shall select 5 Plaintiffs from the discovery group of 20 Plaintiffs, and rank them from 1 to 5 for inclusion on the 5/30/2006 trial docket, with No. 1 being the first Plaintiff of this group on the trial docket.
- 11/30/2005 Plaintiffs have until this date to designate experts. No additional experts will be allowed to testify at trial except on good cause shown. The designation of expert witnesses shall include information identified in Tex.R.Civ.P. 194.2.
- 12/31/2005 Defendants have until this date to designate experts. No additional experts will be allowed to testify at trial except on good cause shown. The designation of expert witnesses shall include information identified in Tex.R.Civ.P. 194.2.
- 1/23/2006 Deadline for completion of depositions of all parties, fact witnesses and expert witnesses in the 5 plaintiffs ranked 1 to 5 for trial.
- 1/31/2006 Plaintiffs' amended pleading deadline.
- 2/13/2006 Defendants' amended pleading deadline.
- 2/6/2006 All motions other than motions in limine shall be filed by this date, unless leave of court is obtained to do otherwise. This includes motions for summary judgment and motions to exclude experts (Daubert or Havner motions)

- 3/2/2006 Submission date for all motions for summary judgment. No motions for summary judgment will receive oral hearings.
- 3/9/2006 Parties to exchange exhibit lists, motions in limine, page/line designations.
- 3/16/2006 Deadline to counter-designate exhibits and page/line designations.
- 3/20/2006 Pretrial conference will begin at 9:00 a.m. Deadline to exchange exhibits.
- 5/30/2006 Trial begins at 9:00 a.m.
