POSITION DESCRIPTION

Summary Statement of Work Performed:

The Assistant Criminal District Attorney (ADA) will prosecute all felony and misdemeanor cases assigned to the County Court at Law of Cass County, Texas. He/she will be responsible for receiving and reviewing new cases and preparing those cases for filing, either as a misdemeanor or felony. For felony cases, he/she will prepare indictments and present such cases to the grand jury. The ADA will be in charge of all pleadings and correspondence necessary for discovery and trial, or rejection and dismissal of such cases.

In addition to the above primary duties, the ADA shall file and litigate all asset forfeiture cases and will assist law enforcement in the preparation of affidavits regarding such forfeitures. The ADA is also responsible for responding to and litigating all requests for occupational licenses, should they be opposed.

Lastly, the ADA may occasionally be required to fill in for the other attorneys in the office in handling mental commitments, hearings before the JP courts (including class C misdemeanor cases and bond hearings), juvenile cases, and Drug Court.
