<p><b>Summary Statement of Work Performed:</b> Detention officers provide supervision of inmates at the Cass County Jail including, but not limited to, hourly checks on inmate welfare, distribution of prescribed medications, distribution of meals, pickup and delivery of inmate laundry, supervision of inmate recreation time and searching newly booked and work release inmates. Must be able to follow set procedures for booking and releasing inmates. Must be able to keep accurate records, both with and without aid of the computer. The jail is staffed 24 hours a day and Detention Officers must be able to work shifts.</p>

Some computer skills helpful but not necessary, as department will train new employees. Position requires considerable walking and standing. Frequent bending, stooping and reaching are required, along with some lifting. Must be able to deal effectively with stress. Must be able to follow standard operating procedures, Jail Standard Guidelines, and written and oral instructions from supervisors.</p>
