

ORDER GRANTING PETITION TO CREATE CASS COUNTY EMERGENCY SERVICES
DISTRICT NUMBER # 9

On this the 12th day of May, 2026, came to be heard a Petition proposing the creation of Cass County Emergency Services District Number 9, and all issues in respect to the creation of such proposed district.

WHEREAS, a public hearing was held at which any person interested may appear before the Court in person or by attorney and contend for or contest the creation of such District, and offer testimony pertinent to any issues thereon; and

WHEREAS, the organization of a district as prayed for is feasible and practicable, would benefit the land included therein, and will be conclusive to the public safety, welfare and convenience, and aid in the conservation of the real property or natural resources within said district;

THEREFORE, the Commissioners Court of Cass County so finds and grants the petition and fixes the boundaries as follows: SEE ATTACHED LEGAL DESCRIPTION


FURTHER, the Commissioners Court of Cass County hereby orders that the following proposition be presented to the voters within the proposed district, and added to the ballot for the General Election to be held November 3, 2026:

CONFIRMATION OF THE CREATION OF CASS COUNTY EMERGENCY SERVICES DISTRICT #9 AND THE LEVY BY THE DISTRICT OF A TAX OF UP TO TEN CENTS ON EACH \$100 OF THE TAXABLE VALUE OF PROPERTY TAXABLE BY THE DISTRICT.



PROPOSED ESD 9

BOUNDARIES

East Side:

Beginning at CR 3217, from CR 2225 going north, west side of road only, to SH 77 west.

FM 2791 - west side of road only from SH 77 west to CR 2116.

FM2791 - north side of road only from CR 2116 to FM96.

FM 96 - west side of road only, going north to CR 3561. CR 3561 west side only to Wright Patman Lake.

South Side:

Cr 2225 both sides from CR 3217 to SH 8.

SH 8 both sides to CR 2341.

CR 2341 – from SH 8, north side only, to CR 2340.

CR 2340 – east side only from CR 2341 to CR 2339.

CR 2339 – north side only to CR 2345.

West Side:

CR 2345 - both sides, east and west of CR 2345 from CR 2339 to SH 77 west.

SH 77 west – south side only to FM 2065, east side only to CR 2471.

CR 2471 – east side only to Shell Oil plant.

North Side:

CR 2471 – from west side boundary to CR 3561; all north roads end at Wright Patman Lake.

Wright Patman Lake – from CR 2471 to CR 3561 is north boundary.
